

Privacy Policy

1. General Provisions

This Privacy Policy complies with U.S. and international data protection standards and applies to the processing of personal data by Emil Sharifulin, acting as the Data Controller (hereinafter — the “Operator”).

1.1. The Operator values the protection of individual rights and freedoms, including the right to privacy and confidentiality, in all aspects of personal data processing.

1.2. This Policy applies to all information that the Operator may collect from visitors of the website <https://emilproduction.ru/los-angeles/>.

2. Key Definitions

2.1. *Automated processing* — processing of personal data using computer systems.

2.2. *Blocking of personal data* — temporary suspension of data processing.

2.3. *Website* — a set of information and digital assets available online at

<https://emilproduction.ru/los-angeles/>.

2.4. *Personal data information system* — a system containing databases and tools used for personal data processing.

2.5. *Anonymization* — actions making it impossible to identify the data subject without additional information.

2.6. *Processing of personal data* — any operation performed with personal data, including collection, recording, storage, updating, use, transfer, blocking, or deletion.

2.7. *Operator* — a legal or natural person determining the purposes and methods of personal data processing.

2.8. *Personal data* — any information relating directly or indirectly to an identified or identifiable user of the website.

2.9. *User* — any visitor of the website <https://emilproduction.ru/los-angeles/>.

2.10. *Provision of personal data* — disclosure of personal data to specific persons.

2.11. *Dissemination of personal data* — disclosure of personal data to an unlimited number of persons.

2.12. *Cross-border transfer* — transfer of personal data to a foreign country or organization.

2.13. *Destruction of personal data* — irreversible deletion of personal data or physical destruction of media containing such data.

3. Rights and Responsibilities of the Operator

3.1. The Operator has the right to:

- Request accurate and up-to-date data from the User.
- Continue processing data when legally justified.
- Determine the necessary security measures to ensure protection.

3.2. The Operator must:

- Provide Users with information about personal data processing upon request.
- Process data in compliance with applicable U.S. and international data protection laws.
- Respond to User requests regarding data rights.
- Implement organizational and technical measures to protect personal data.
- Maintain confidentiality and terminate processing when required.

4. Rights and Responsibilities of Users

4.1. Users have the right to:

- Access their personal data.
- Request correction, blocking, or deletion of inaccurate data.
- Withdraw consent at any time.
- Object to unauthorized processing.

4.2. Users must provide accurate and updated information.

5. Principles of Personal Data Processing

5.1. Data is processed lawfully, fairly, and transparently.

5.2. Only relevant and necessary data are collected.

5.3. Data accuracy and timeliness must be ensured.

5.4. Storage is limited to what is necessary for the purpose of processing.

6. Purpose of Processing

Personal data is collected and processed to:

- Communicate with Users via email or phone.
 - Provide services and fulfill contractual obligations.
 - Improve website functionality and user experience.

7. Conditions of Processing

7.1. Personal data is processed with the User's consent.

7.2. Processing may also occur when required by law or public interest.

7.3. Users may withdraw consent by contacting **info@emilproduction.ru**.

8. Collection, Storage, and Transfer

8.1. Personal data is securely stored and protected from unauthorized access.

8.2. Data is not shared with third parties without consent, except as required by law.

8.3. Users may update their data by contacting **info@emilproduction.ru**.

8.4. Third-party service providers may process data under their respective privacy policies, ensuring comparable protection.

9. Actions Performed by the Operator

The Operator collects, records, organizes, stores, updates, uses, transmits, anonymizes, blocks, deletes, and destroys personal data in accordance with applicable laws.

Automated processing may include data transmission via secure networks.

10. **Cross-Border Data Transfer**

10.1. Any cross-border transfer of personal data shall comply with applicable U.S. and international laws and occur only after ensuring appropriate protection measures.

11. **Confidentiality**

The Operator and authorized personnel shall not disclose personal data without User consent, except as required by law.

12. **Final Provisions**
